PORT OF MELBOURNE BOOTH PIER AND REID STREET PIER WORKS EXCLUSION ZONE

Date: 18 January 2024

Refers: NtM 314 (T) – 23 and is hereby cancelled.

Details: Mariners are advised that demolition and removal works of Booth Pier and Reid Street Pier have been **extended until approximately 31 March 2024.**

The following vessels will be involved in the demolition and removal works:

- SEP FUJI UVI 415516
- Dumb Barge Gippsland UVI 859158
- Jack Up Barge 2 UVI 448924
- Steel Punt Barge 92 UVI 433799
- Support vessels: MV Condor UVI 432775, MV Walrus UVI 451048, MV Stay Calm - UVI 453777

Works will be conducted by Fitzgerald Constructions from **Monday to Saturday** during **daylight hours**. The works supervisor may be contacted on **0427 066 661**.

In accordance with attached Government Gazette Notice – *No. G3 Thursday 18 January 2024* – *Notice controlling navigation in the vicinity of works* – an exclusion zone surrounding the works area at Booth Pier and Reid Street Pier is currently in force until **1800hrs 31 March 2024**.

The exclusion zone for the works area is marked by special mark buoys, with light characteristics FI.Y.4s, in the following deployed positions:

All vessels, excluding those authorised, are prohibited from entering the exclusion zone surrounding Booth Pier and Reid Street Pier. Mariners are advised to navigate with additional caution in the vicinity of the works exclusion zone.

NOTICE CONTROLLING NAVIGATION IN THE VICINITY OF WORKS

Ports Victoria, as the port management body for the port waters of the Port of Melbourne makes the following notice under section 211(1)(b)(i) of the Marine Safety Act 2010 (the Act).

For the purposes of the works activity proposed by Fitzgerald Constructions Australia for demolishing Booth Pier and Reid Street Pier, all vessels and persons are prohibited from entering or remaining in the waters detailed below, excluding vessels directly engaged in the works, emergency response vessels or vessels or persons otherwise authorised by Ports Victoria.
